Reuse : to put into action or service again

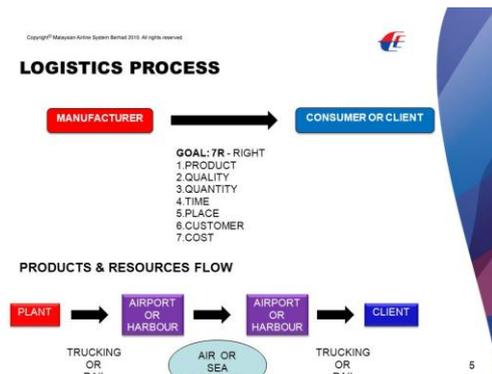
Respect : treat with consideration
